### **1. Introduction**

### **4. Cancellation and Refunds**

- A refund is only available if your cancellation is received 7 days prior to the retreat.
- No refunds will be issued for cancellations made after that date or for early departures.
- In the event the retreat is cancelled by the organisers, a full refund will be issued.
